Make-Up Pass Policy

Make-ups are only issued during illness, injuries, or a coaching change. You must approach the skating directors in advance to receive a pass. That pass must be in possession when signing in for makeup session.

Freestyle Session Fees

“Figure Skating” members of the Phillips Academy Skating Club (PASC) may contract Freestyle sessions for a “season” at a time at a reduced rate. Walk-ons will be accepted as space permits, with members of the PASC given priority at a discounted rate.

Release of Liability
